<b>Status of Residence</b>	Who can submit the application for certificate of eligibility on behalf of the foreign national seeking landing
<b>Diplomat</b>	<ol style="list-style-type: none"> <li>1. Personnel of the diplomatic mission, consular office or other organization, to which the person concerned or the person's family member belonging to the same household belongs.</li> <li>2. Family member belonging to the same household.</li> </ol>
<b>Official</b>	<ol style="list-style-type: none"> <li>1. Personnel of the office in Japan, of a foreign country or international organization, to which the person concerned or the person's family member belonging to the same household belongs.</li> <li>2. Family member belonging to the same household.</li> </ol>
<b>Professor</b>	Personnel of the educational institution in Japan for which the person concerned is going to work.
<b>Artist</b>	Personnel of the organization in Japan, with which the person concerned has a contract, or to which he or she belongs for engaging in artistic activities
<b>Religious Activities</b>	Personnel of the branch office or other relevant religious organization in Japan or foreign religious organization which is sending the person concerned.
<b>Journalist</b>	Personnel of the organization in Japan or the foreign journalistic organization in Japan which has a contract with the person concerned ; or personnel of the organization in Japan to which the person concerned belongs for engaging in journalistic activities.
<b>Investor/Business Manager</b>	Personnel of the corporation in Japan for which the person concerned is going to engage in operation or management.
<b>Legal/Accounting Services</b>	Personnel of the legal or accounting organization in Japan which has a contract with the person concerned or to which the person concerned belongs for engaging in legal or accounting services.
<b>Medical Services</b>	Personnel of the medical institution in Japan which has a contract with the person concerned or to which the person concerned belongs for engaging in medical services.
<b>Researcher</b>	Personnel of the organization in Japan which has a contract with the person concerned.
<b>Instructor</b>	Personnel of the educational institution to which the person concerned belongs for engaging in instruction.
<b>Engineer</b>	Personnel of the organization in Japan which has a contract with the person concerned.
<b>Specialist in Humanities/International Services</b>	Personnel of the organization in Japan which has a contract with the person concerned.

<b>Intra-company Transferee</b>	Personnel of the business office in Japan to which the person concerned is going to be transferred.
<b>Entertainer</b>	Personnel of the organization in Japan which invites the person concerned or to which the person concerned belongs for engaging in show business.
<b>Skilled Labor</b>	Personnel of the organization in Japan which has a contract with the person concerned.
<b>Cultural Activities</b>	<ol style="list-style-type: none"> <li>1. Personnel of the organization in Japan to which the person concerned belongs, for engaging in academic or artistic activities.</li> <li>2. Expert who is going to guide the person concerned.</li> <li>3. Relative, living in Japan, of the person concerned.</li> </ol>
<b>College Student</b>	<ol style="list-style-type: none"> <li>1. Personnel of the educational organization in Japan at which the person concerned is going to study.</li> <li>2. Personnel of the organization which offers scholarship to the person concerned or is going to pay the tuition fees or living expenses incurred by the person concerned.</li> <li>3. Person who is going to pay the tuition fees or living expenses incurred by the person concerned.</li> <li>4. Relative, living in Japan, of the person concerned.</li> </ol>
<b>Pre-college Student</b>	<ol style="list-style-type: none"> <li>1. Personnel of the educational organization in Japan at which the person concerned is going to study.</li> <li>2. Personnel of the organization which has established the student exchange program, if the person concerned is coming to Japan under that program.</li> <li>3. Relative, living in Japan of the person concerned, if he or she is going to study at high school (including the latter course of secondary educational school).</li> </ol>
<b>Trainee</b>	Personnel of the organization in Japan which accepts the person concerned.
<b>Dependent</b>	<ol style="list-style-type: none"> <li>1. Person who is going to support the person concerned in Japan or relative, living in Japan, of the person concerned.</li> <li>2. Person who applies or has applied for the certificate of eligibility on behalf of the principal foreign national who supports the person concerned.</li> </ol>
<b>Designated Activities</b>	<ol style="list-style-type: none"> <li>1. Personnel of the organization to which the person concerned belong for the activities designated by the Minister of Justice.</li> <li>2. Employer of the person concerned.</li> </ol>
<b>Spouse or Child of Japanese National</b>	Relative, living in Japan, of the person concerned.
<b>Spouse or Child of Permanent Resident</b>	Relative, living in Japan, of the person concerned.

<b>Long Term Resident</b>	Relative, living in Japan, of the person concerned.
